PROFIT WARNING

This announcement is made by Hong Kong Jewellery Holding Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the Growth Enterprise Market (“**GEM**”) of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Based on the preliminary review by the board (the “**Board**”) of directors (the “**Directors**”) of the Company of the unaudited consolidated management accounts of the Group for the year ended 31 December 2013, the Board wishes to inform the shareholders (the “**Shareholders**”) of the Company and the potential investors that the Group expects to record a significant loss attributable to owners of the Company for the year ended 31 December 2013 as compared with the profit attributable to owners of the Company for the year ended 31 December 2012. The Board considers that such loss was mainly attributable to the significant increase in costs of promotion and development expenses incurred by the Group for its ambitious expansion in the jewellery business.

As the Company is in the process of finalizing its results for the year ended 31 December 2013 (the “**2013 Annual Results**”), the information contained in this announcement is only a preliminary assessment by the Board based on the information currently available to the Company and the unaudited consolidated management accounts of the Group for the year ended 31 December 2013. The 2013 Annual Results are expected to be approved and announced by the Board on 17 March 2014. Shareholders and potential investors are advised to read the announcement of the 2013 Annual Results carefully when it is published.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
