This announcement is made by Guangzhou Baiyunshan Pharmaceutical Holdings Company Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Cap 571 of the Laws of Hong Kong) and Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

Unless otherwise specified, capitalised terms used in this announcement have the same meanings as those defined in the inside information announcement of the Company dated 26 December 2017 (“**December Announcement**”).

1. BACKGROUND

In the December Announcement, it was disclosed, among other things, that pursuant to the Arbitration Ruling, Golden Force was ordered to transfer 98,378,439 shares in Wang Lao Ji to the Company.

2. APPLICATION FOR REVOCATION OF THE ARBITRATION RULING

The Company announces that it received an application for revocation of arbitration ruling (“**Revocation Application**”) submitted by Golden Force to the Shenzhen Peoples’ Intermediate Court* (深圳市中級人民法院) wherein Golden Force applied for the revocation of the Arbitration Ruling.

The Company will seek legal advice on the Revocation Application and, where necessary or appropriate, issue further announcement(s).
